

The Roy L. Shafer Leading Edge Awards are presented annually to ASTC members and/or their employees in recognition of extraordinary accomplishments in Visitor Experience, Business Practice, and Leadership in the Field that not only enhance the performance of their own institutions, but also significantly advance the mission of science centers and museums.

The Roy L. Shafer Leading Edge Award for **Leadership in the Field** recognizes up to two individuals annually: one who serves in the chief executive leadership role (CEO/executive director) of an ASTC-member institution and one who serves another, non-chief executive role at an ASTC-member institution. Nominations will be judged according to the individual's degree of success at applying new ideas and/or enhancing best practices; embodying the ASTC values of collaboration, joy of experiential learning, equity and diversity, and forward-looking leadership; and demonstrating the potential to inspire and nurture creative thinking. The individual's success at having a tangible and lasting impact on the organization's mission; building relationships for his or her institution within the community; and developing the current talents/capabilities and nurturing the future capacity of staff will also be considered.

Eligibility: Individuals with an exemplary accomplishment in the past three years (since January 2015) who are employed by ASTC-member institutions in good standing are eligible. Each nominating institution is limited to one nomination per category per year. Nomination forms must be signed by the institution's chief executive officer, board chairperson, or equivalent. Nominations from the home institution of a Leading Edge Awards jury member will not be considered.

Selection: An eight-member jury of professionals knowledgeable about the science center field, representing a broad spectrum of ASTC's worldwide membership, will review entries and select finalists. Once detailed nomination information is submitted, the jury will review all finalists and select awardees. All decisions of the jury are final, including the decision not to choose an award recipient in a given category.

Awards Ceremony and Recognition: The 2018 Leading Edge Awards will be presented during the ASTC Annual Conference in Hartford, Connecticut. Each award will consist of an etched glass "Edgie" and a complimentary full conference registration to the 2018 ASTC Annual Conference (fees for special events, tours, and workshops are not included). Awardees will receive recognition in *Dimensions* magazine, on the ASTC website, and in a widely distributed press release. Awardees will also receive a special award winner logo to display on their website or other promotional material, and a press release to assist them in publicizing their recognition.

Each narrative must address the required criteria (#1, #2, and #3). Bulleted points can be addressed as appropriate for additional support of the nomination.

Use a specific exemplary accomplishment since January 2015 to describe the nominee's degree of success during the last three years at

1. applying new ideas and/or enhancing best practices
2. embodying the ASTC values of collaboration, joy of experiential learning, equity and diversity, and forward-looking leadership
3. demonstrating the potential to inspire and nurture creative thinking
 - having a tangible and lasting impact on the organization's mission
 - building relationships for his or her institution within the community
 - developing the current talents/capabilities and nurturing the future capacity of staff.

Letters of Support

Include two or more letters of support (one page each) from individuals with first-hand knowledge of the nominee's work.

For nominations of chief executives, please ensure that letters of support come from independent sources. For nominations of non-chief executives, one letter from the chief executive of the nominee's institution is required. Additional letters of support should come from independent sources.

Letters of support must address the following:

- Explain your relationship to the nominee and describe his/her exemplary accomplishment during the past three years that is the basis of your nomination.
- Describe why you think this accomplishment deserves recognition.
- List the most significant benefits of the nominee's accomplishment, as you see them.

- Check here to grant permission to distribute information about your nomination to the science center field. Information will not be used for commercial purposes without permission of the chief executive of the science center or museum.
